24 **ORDER TO CONDUCT RECOUNT**

25 **Priority Case—A.R.S. § 16-663(A)**

26 The facts requiring a recount of the votes cast in the August 2, 2022 Primary Election
27 for the Democratic Party nominee for Justice of the Peace for the West McDowell Precinct
28 having been certified to this Court,

IT IS ORDERED pursuant to A.R.S. §§ 16-624(D) and 16-663 that:

A. A recount of the votes cast in the 2022 Primary Election for the Democratic
Party nominee for Justice of the Peace for the West McDowell Precinct shall be conducted;

B. The recount shall be conducted by the Maricopa County Board of
Supervisors;

1 C. The Board of Supervisors, as the Secretary of State's designee, shall furnish
2 and program an automatic tabulating system and conduct logic and accuracy testing on it as
3 prescribed by law;


4 D. The Board of Supervisors may satisfy A.R.S. § 16-664(C) by reprogramming
5 the automatic tabulating system to recount only the votes cast in the 2022 Primary Election
6 for the Democratic Party nominee for Justice of the Peace for the West McDowell Precinct;

7 C. All participants to the recount shall keep confidential any information they
8 may acquire that would disclose the vote of any elector and shall destroy any notes that
9 would disclose the same;

10 D. A hearing for the presentation of the results of the recount and this Court's
11 determination of the same, pursuant to A.R.S. § 16-665, is set for August 24, 2022 at
12 8:30 a.m.; and,

13 E. If the Board of Supervisors completes the recount in sufficient time to allow
14 the hearing for the presentation of the results to be conducted earlier than August 24, 2022,
15 the Petitioners shall notify the Court and the candidates and shall move this Court for an
16 Order resetting the hearing date to the earliest possible date and time.
